1. Interpretation

The following definitions and rules of interpretation in this clause apply in these terms and conditions:

1.1 Definitions:

Charges: the charges in respect of the Services set out in the Contract or otherwise agreed in writing between the parties.

Confidential Information: all information, whether technical or commercial (including all specifications, drawings and designs, disclosed in writing, on disc, orally or by inspection of documents or during discussions between the parties), where the information is:

(a) identified as confidential at the time of disclosure; or

(b) ought reasonably to be considered confidential given the nature of the information or the circumstances of disclosure.

Conditions: these terms and conditions.

Contract: the contract between the Client and Hulme Tech for the provision of the Services by Hulme Tech to be performed on and subject to these Conditions.

Client: the person or firm who purchases Services from Hulme Tech.

Data Protection Legislation: up to but excluding 25 May 2018, the Data Protection Act 1998 and thereafter (i) unless and until the GDPR is no longer directly applicable in the UK, the GDPR and any national implementing laws, regulations and secondary legislation, as amended or updated from time to time, in the UK and then (ii) any successor legislation to the GDPR or the Data Protection Act 1998.

GDPR: General Data Protection Regulation ((EU) 2016/679).

Intellectual Property Rights: patents, copyright and related rights, moral rights, trade marks, domain names, the right to sue for passing off or unfair competition, rights in designs, rights in computer software, database rights, rights to use, and protect the confidentiality of, confidential information (including know-how and trade secrets) and all other intellectual property rights, in each case whether registered or unregistered and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world.

6. Domain name

6.1 Hulme Tech does not warrant that any particular domain name specified by the Client will be available for use by the Client.

6.2 If the Client requests the registration of a specific domain na me, Hulme Tech will apply for the registration of the domain name on the Client's behalf and at the Client's cost subject to availability of the domain name in question at the time of the application and subject to the terms and conditions of the relevant domain name registry.

6.3 Any domain name registration successfully completed will be in the name of Hulme Tech whose name and address will be shown as the registered owner of the domain name. Subject to payment of all Charges due and the costs of the application and expenses incurred by Hulme Tech in respect of the registration, Hulme Tech agrees to transfer its rights in the domain name to the Client within 30 days of request in writing. Unless otherwise agreed the Client shall be responsible for all annual and other renewals of the domain name registration and all costs in respect of the same.

6.4 The Client shall be responsible for ensuring that the registration of any domain name requested by the Client for the Client does not infringe any trade mark, copyright or other right of any person and agrees to indemnify and keep indemnified Hulme Tech in relation to all costs, claims, losses and expenses of Hulme Tech arising in connection with the registration by Hulme Tech of the domain name.

7. Hosting services, Training, maintenance and SEO services

7.1 Hulme Tech will provide hosting services (Hosting Services) for the Site only where expressly agreed by Hulme Tech in writing. Unless otherwise expressly agreed, the Client shall be responsible for the hosting of the Site.

7.2 Provision by Hulme Tech of any Hosting Services is subject to payment by the Client of annual hosting fees notified from time to time by Hulme Tech and payable in advance and such further terms in respect of the hosting of the Site as may be agreed.

7.3 Subject to payment by the Client of the fees and Charges due in respect of Hosting Services, Hulme Tech warrants on delivery and for a warranty period of thirteen weeks from the date that the Site is in Live Mode that the Site provides the functionality set out in the Specification and is free of coding errors and cross browser issues. Hulme Tech agrees, subject to its fair usage policy and for so long as Hulme Tech remains instructed to host the Site, to provide reasonable support services during such warranty period.
